### **Introduction to Restorative Practices:**

- ☐ Restorative Practices for Administrators (20-35 participants)  
*One-day training for administrative-level staff. Provides an overview of Restorative Practices and implementation strategies.*
- ☐ Overview of Restorative Practices (20-35 participants per session)  
*One-day of training for all school staff (certificated and classified) divided into two 3-hour sessions. Provides an overview of Restorative Practices.*
- ☐ Restorative Practices Skills and Circles (20-35 participants)  
*Two-day training for school staff working directly with students. Provides an in-depth foundation of Restorative Practices and skills practice with the Restorative Continuum.*

\*Please note that the above services are designed to provide varying levels of Restorative Practices foundational training based on participants' intended usage of Restorative Practices. It is not recommended that participants attend multiple introductory courses, as there will be overlap of information.

### **Expanded Restorative Practices:**

*For districts experienced with Restorative Practices implementation*

- ☐ Formal Restorative Conferencing (15-25 participants)  
*Two-day training for staff experienced in Restorative Practices. Provides training in facilitating restorative conferences.*
- ☐ Strengthening and Sustaining Restorative Practices (20-35 participants)  
*One-day training for previously trained and experienced staff. Provides skills and tools to enhance and expand restorative impact.*
